### Minutes of the Meeting

1. Call to order  
There being a quorum present, the meeting was called to order at 6:03 PM.
2. Public Comment  
No public comment was made.
3. Discussion and possible action to accept resignation of Bobby Brown.  
Director Morrison moved that the Board accept resignation of Bobby Brown. Director Minze seconded. **Motion carried.**
4. Introduction of Director Kyle Eppler representing rural water supply interests of Grimes County for the remainder of the unexpired term ending January 2016.  
GM Holland presented Director Kyle Eppler to the Board.
5. Approve Bonds for Re-Appointed Directors and Director Kyle Eppler.  
Director Morrison moved that the Board approve bonds for re-appointed Directors and Director Kyle Eppler. Director Thomas seconded. **Motion carried.**
6. Presentation by James Ingram and discussion of FY 2013 Audit performed by Ingram, Wallis & Company.  
Mr. Ingram presented the FY 2013 Audit to the Board, specifically referencing the attached letters detailing the Audit.
7. Discussion and possible action to accept FY 2013 Audit prepared by Ingram, Wallis & Company.
