- a. Well Registration/Permitting  
GM Behm reported that the following number of wells have been registered or permitted in the District: Exempt wells, 936; Non-exempt wells, 143; RRC wells, 50; Test wells, 1; Monitoring wells, 77; transportation permits, 1.
- b. Office Staffing  
GM Behm reported that Administrative Assistant Morgan had quit on 3/28/2006. He currently is interviewing applicants for the position.
- c. GMA Joint Planning
  - (1) GMA 11  
GM Behm continues to work with TWDB to remove a small portion of Walker County from GMA 11 so that the District will only be involved in the planning process in GMA 14. GMA has not scheduled any meeting as of this date.
  - (2) GMA 14  
GMA 14 has held 2 planning meetings with the next meeting scheduled for 5/23/06. GM Behm serves as Chairman of this planning group. This GMA plans to finish the process and have Desired Future Conditions of the aquifers and Managed Available Groundwater determinations completed by the fall of 2007.
- d. District response to General Land Office proposed amendments to Texas Administrative Code.  
GM Behm reported that the District submitted comments to the Texas General Land Office regarding proposed rules of the GLO and the School Land Board relating to groundwater leasing and the exploration and development of groundwater resources on state land.
